## Nurses Notes

### Do you know the difference between a National Weather Service Severe Thunderstorm Watch and a Severe Thunderstorm Warning?

**Severe Thunderstorm Watch: Be Prepared!** Severe thunderstorms are possible in and near the watch area. Stay alert. Look for storms. Be ready to act.

**Severe Thunderstorm Warning: Take Action!** Severe weather has been reported by spotters or indicated by radar. Warnings indicate approaching danger to life and property. People may be hurt in the storm. Homes and buildings may be damaged. Protect yourself. Take action now.



### What you can do when severe weather strikes. Acting quickly is key to staying safe.

- **Stay Weather Ready:** Continue to listen to local news or a NOAA Weather Radio to stay updated about severe thunderstorm watches and warnings.
- **At Your House:** Go to your secure location, like your bathroom, if you hear a severe thunderstorm warning. Damaging wind or large hail may be approaching. Take your pets with you if time allows. Stay away from windows if there is a severe thunderstorm warning.
- **Outside:** Go inside a sturdy building immediately if severe thunderstorms are approaching. Sheds and storage facilities are not safe. Taking shelter under a tree can be deadly. The tree may fall on you. Standing under a tree also put you at a greater risk of getting struck by lightning.

If your unit is selected you will receive a notice of entry from me by October 15, 2019.

### Pay your rent through ACH

ACH payments are electronic payments that are created when the customer gives an originating institution, corporation, or other customer (originator) authorization to debit directly from the customer's checking or saving account for the purpose of bill payment.

This is the preferred method to pay your rent. If you are interested in this option, please come to the main office to fill out the proper paperwork.

- **In a Vehicle:** Being in a vehicle during severe thunderstorms is safer than being outside; however, drive to closest secure shelter if there is enough time.

### **Scams Involving the Impersonation of a Social Security Administration (SSA) Employee**

The Office of the Inspector General receives reports where individuals have been contacted by someone pretending to be an SSA employee. The intent of this type of call may be to steal your identity and/or money from your bank accounts. The caller generally asks you for personal information such as your Social Security number, date of birth, your mother's maiden name, or your bank or financial account information.

The impersonator may state that "the SSA computers are down" or may refer to enrollment in the Medicare prescription drug program. The intent of this type of call may be to steal your identity and/or money from your bank accounts. You should not provide any of this information to these individuals.

It is possible that an SSA employee may contact you to follow-up on a previous application for SSA/Medicare Part D benefits or to follow-up on other business you initiated with SSA.

If you wish to report a call from someone you suspect is impersonating an SSA employee, through the [OIG Fraud Hotline](#), please provide us with the following details:

- Caller's alleged name
- Caller's telephone number
- Time and date the call was made
- Information requested by the caller
- Other identifying information or details about the content of the call
