FSS Gradation: I forgot to mention we had an FSS graduation in May 2021. This FSS participant had found full time employment almost immediately when she join the FSS program in May 2017 and is now graduating May 2021. She has worked hard to better herself and her family while on the FSS program. She ran her credit report, tracked her spending, made a budget, met with FISC for financial management, maintained budget for 3 months, paid off small debts, updated her resume, created a cover letter, increased her credit score from 459 to 601, and found a full time job as a CNA. She is saving her FSS escrow of \$9292 to buy a home. Congrats!

Oshkosh/Winneconne Back To School Fair: The Back to School Fair will be changing this year. We will be limiting contact with family and friends but we will continue to provide school supplies, hygiene, shoes and clothing. ARE YOU STRUGGLING TO PAY **RENT, UTILITIES, AND OTHER BILLS** DUE TO THE COVID-19 PANDEMIC?

The Wisconsin Emergency Rental Assistance Program (WERA) assists qualifying households with up to 12 months assistance for current and/or overdue payments:

▶ Rent payments ▶ Utility and home energy

DO I QUALIFY? -

Your household may qualify if at least one or more individuals:

- Is eligible for unemployment, has experienced a reduction in household income, or has incurred major costs or financial struggles due to the COVID-19 pandemic.
- Is at risk of being evicted.
- Has a household income at, or below, 80 percent of the county median.

Help Is Here Monthly payments for families with kids

Raising kids can be expensive, and the Child Tax Credit is here to help. President Biden's American Rescue Plan increased the amount of the 2021 Child Tax Credit to support families with children.

The full benefit of the Child Tax Credit is now \$300 per month per child under age 6 and \$250 for each child age 6 to 17.

Did you file taxes in the last 2 years? Then you don't have to do anything to get the money you're already owed!

If you filed your 2020 taxes this year or filed your 2019 taxes last year, or used the IRS "Non-Filer Portal" to get a stimulus check last year, you don't need to do anything. The IRS will automatically send you a monthly payment by direct deposit or check starting on July 15, 2021.

The Child Tax Credit is \$3,000 to \$3,600 per child with advanced monthly payments.

In order to get money to families quickly, the IRS will pay half of the credit as monthly payments now and the other half when you file your taxes next year. In total, you'll receive a total of \$3,600 for each child under 6 and \$3,000 for each child between 6 and 17.

Didn't file taxes in the last 2 years? There's 1 easy step to start getting your Child Tax Credit payments.

Just fill out a simple form to begin receiving your monthly Child Tax Credit payments. You can access it by going to childtaxcredit.gov

You'll need this information to apply:

- Social Security Numbers for you and your children
- A reliable mailing address
- E-mail address
- Your bank account information (if you want to receive your payment by direct deposit)

Eligibility: Most families, even those with little to no income, can receive the full amount. If you are a single parent making less than \$112,500 or a married couple making less than \$150,000—and have children under age 18 who will live with you for more than half of 2021—you are likely eligible for the full benefit. These benefits do not affect your eligibility for other federal benefits like SNAP.

Young Women's Initiative: Starting Point 2.0


The Women's Fund is leading a project using a Two-Generation approach which will address the life-long economic security of single parent women and their children. This project creates a collaboration between FVTC's Starting Point Workshop and the college's educational resources combined with B.A.B.E.S. Inc. and their child development/parenting programming. By serving two-generations and creating a new stable environment for single-parent families, individuals struggling to survive will see the opportunities and potential that exist beyond their circumstances. This workshop and services provided are free to participants and children.

Participant Criteria:


- 18-35 year old single parent woman
- Income level must be at or below 200% of the Federal Poverty Guideline
- Must have at least one child under the age of 11
- Must reside in one of the following counties: Calumet, Outagamie, Shawano, or Waupaca, and communities of Neenah & Menasha

Project Details:

Parent and any child under the age of 5 will attend B.A.B.E.S. Inc. together. School age children under 11 will participate through take home activities. Wednesdays, September 15, 2021 through December 1, 2021 from 11:00 am to 2:00 pm. The last 4 weeks parents will transition to class at Fox Valley Technical College-Appleton Campus while the children remain at B.A.B.E.S. Inc.



We are excited to share information about a new benefit program called the Emergency Broadband Benefit (EBB) program, that's designed to help low-income Americans connect to the internet!

This federal benefit program helps qualified households by providing

- Up to \$50/month discount for broadband service
- Up to \$75/month discount for households on qualifying Tribal lands
- A one-time discount of up to \$100 for a laptop, desktop computer, or tablet purchased through a participating provider if they contribute more than \$10 but less than \$50 toward the purchase price.

Time is limited to access these funds! The EBB program will end when the fund runs out, or six months after the Department of Health and Human Services declares an end to the COVID-19 health emergency, whichever is sooner.

Participants who have experienced job loss, or currently use lifeline program (such as Medicaid and SNAP), can apply for the benefits through the <u>FCC-created Web site</u>. Thanks to our partnership with Comcast, Goodwill beneficiaries can use their EBB benefits to access discounted internet and equipment through the Internet Essentials program. Other eligibility details

If You Experienced a Job Loss or Furlough

If you experienced a substantial loss of income since February 29, 2020 because you lost your job or were furloughed, you may qualify for the EBB Program.

If You Use SNAP, Medicaid, or Other Programs

You can receive the Emergency Broadband Benefit if you (or someone in your household) participates in one of these federal assistance programs:

- Supplemental Nutrition Assistance Program (SNAP), formerly known as Food Stamps
- Medicaid
- Supplemental Security Income (SSI)
- Federal Public Housing Assistance (FPHA)
- Veterans Pension and Survivors Benefit
- Tribal Specific Programs:
 - Bureau of Indian Affairs General Assistance,
 - Tribal Head Start (only households meeting the relevant income qualifying standard).
 - Tribal Temporary Assistance for Needy Families (Tribal TANF)
 - Food Distribution Program on Indian Reservations
- Free and Reduced-Price School Lunch Program or School Breakfast Program, including at US Department of Agriculture Community Eligibility Provision schools
- Received a Federal Pell Grant in the current award year

Nature of work:

Provide direct support to FSS Coordinator with special attention to marketing FSS Program to HCV participants and Public Housing tenants in Winnebago County.

Examples of work may include:

- Scheduling and facilitating meetings with families that may include in-person meetings, telephone and/or video meetings, meetings in resident homes and in an office setting, and meetings at community partner sites.
- Outreaching and recruiting of potential FSS participants with the goal of 15 families enrolled by limited term end date.
- Updating FSS forms.
- Creating FSS letter templates.
- Developing action plans for enrollment in FSS Program.
- Engaging families in goal planning and strategies to support completion of FSS Program.
- Providing budget development and following through guidance to families.
- Guiding residents through the required steps for completion of FSS Program application.
- Maintaining detailed and organized records.
- Calculating income numbers and account balance updates.

The Uninsured

Individuals and Families who:

Individuals and Families who:

- Have high deductibles or waiting periods

How It Works:

- 1. Get your free card available three different ways:
- Print your card from familywize.org
- **Download** the FamilyWize app on your smartphone
- · Call FamilyWize at 800-222-2818 to have a card mailed to you
- 2. Show your pharmacist the FamilyWize card every time you fill a prescription
- 3. Get the lowest price possible from FamilyWize, from the pharmacy, or from your insurance

FamilyWize also provide a free **Drug Price Look-Up Tool**, available on the app and on familywize.org — use it to search local pharmacies for the lowest FamilyWize price on your prescription!
