Social Security Announces 5.9 Percent Benefit Increase for 2022

Social Security and Supplemental Security Income (SSI) benefits will increase 5.9 percent in 2022. The 5.9 percent cost-of-living adjustment (COLA) will begin with benefits payable to more than 64 million Social Security beneficiaries in January 2022. Increased payments to more than 8 million SSI beneficiaries will begin on December 31, 2021. This will also affect those that receive Veterans and Medicare benefits.

Pet Reminders

Please be a responsible pet owner. All animals should be leashed up to 6 feet, on the property, inside and outside. Also please clean up after your dog does its business. Your neighbors and Housing Authority staff should not have to worry about this.

Do Not Use "Flushable" Wipes

"Flushable" wipes are not flushable. Flushing wipes increases the chances that your pipes will get blocked, and causes serious problems for the sewer system in general.

Cigarette butts

Please dispose of cigarette butts in a safe manner. Do not toss them on the ground for others to have to pick up or put them in the building waste baskets.

Bed Bugs

Please immediately report any bugs you see so we can treat your apartment.

Sharps Containers

Residents who use needles or other sharp devices should bring their full sharps containers to the office so that they can safely be recycled by our Housing Authority nurses.

Aluminum Cans No Longer Being Collected

Staff are no longer collecting aluminum cans. Residents are responsible for recycling their own cans. Please do not drop them off downstairs any longer.

Reminder: Masks Are Still Required in the Common Areas of the Building

The Housing Authority still requires that all tenants and guests must wear a mask at all times while in the common areas of the building.
